



ACKNOWLEDGMENT OF RISK, RELEASE OF LIABILITY, AND INDEMNIFICATION AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS. BY SIGNING THIS AGREEMENT, YOU ARE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE HOLY HUNT OUTFITTERS, ITS GUIDES, AGENTS, EMPLOYEES, AND THE LANDOWNERS UPON WHOSE PROPERTY HUNTING ACTIVITIES ARE CONDUCTED.

I, the undersigned participant (hereinafter referred to as the "Participant"), in consideration for being permitted to participate in guided hunting trips, shooting, outfitting services, transport, field processing, and related activities (collectively referred to as the "Activities") organized, hosted, guided, or provided by **Holy Hunt Outfitters LLC** (hereinafter referred to as the "Company"), hereby execute this agreement and unconditionally agree to the terms set forth below:

- 1. INHERENT RISKS OF ACTIVITIES:** I explicitly acknowledge that hunting, shooting sports, and wilderness travel involve significant inherent risks, both known and unknown. These risks include, but are not limited to: the use and discharge of firearms, ammunition, and specialized equipment; exposure to wild animals, dangerous wildlife encounters, venomous reptiles, and insects; navigating rugged, unpaved, swampy, or heavily wooded terrain; inclement and unpredictable weather conditions; traveling via motorized vehicles, ATVs, watercraft, or on foot; activities occurring in darkness or low-light conditions (including thermal predator hunting); and potential actions or negligence of other hunters, guests, or participants. I recognize that these risks can result in severe physical injury, illness, permanent disability, emotional trauma, or death.
- 2. RELEASE AND WAIVER OF LIABILITY:** I hereby release, acquit, forever discharge, and covenant not to sue **Holy Hunt Outfitters LLC**, its owners, members, managers, officers, directors, employees, certified or uncertified guides, independent contractors, agents, and representatives (collectively referred to as the "Company Releasees"), as well as **all owners, lessors, or managers of lands and properties** upon which the Activities take place (collectively referred to as the "Landowner Releasees"), from any and all liability, claims, demands, actions, or causes of action arising out of any damage, loss, personal injury, or death that may occur to me or my property while participating in the Activities, **INCLUDING ANY CLAIMS BASED UPON THE SOLE OR CONCURRENT NEGLIGENCE** of the Company Releasees or Landowner Releasees.
- 3. INDEMNIFICATION AND HOLD HARMLESS:** I agree to indemnify, defend, and hold harmless the Company Releasees and the Landowner Releasees from and against any and all claims, liabilities, losses, damages, costs, or expenses (including reasonable attorneys' fees and legal costs) arising out of, resulting from, or in any way connected to my participation in the Activities, my handling or discharge of firearms, or my presence on the properties utilized by the Company, whether caused by my own actions, omissions, negligence, or otherwise.
- 4. PARTICIPANT RESPONSIBILITIES AND RULES:** I agree to strictly adhere to all federal, state, and local hunting and game laws, as well as all safety protocols, instructions, and rules established by the Company and its guides. I certify that I am legally permitted to possess and use firearms, possess all necessary valid hunting licenses, tags, and permits, and that I am not under the influence of alcohol, controlled substances, or any medication that could impair my judgment or physical capabilities. I agree that the Company reserves the complete right to terminate my participation at any time if a guide deems my behavior unsafe or unlawful.

5. **MEDICAL CONSENT AND AUTHORIZATION:** I certify that I am in good physical health and have no medical conditions that would endanger myself or others while participating in the Activities. In the event of an injury or medical emergency during the Activities, I hereby authorize the Company and its representatives to secure medical treatment, emergency transportation, or first-aid care on my behalf, and I agree to assume full responsibility for all financial costs associated with such treatment or transport.

6. **GOVERNING LAW AND SEVERABILITY:** This Agreement shall be governed by, construed, and enforced in accordance with the laws of the State in which the Activities primarily take place, without regard to its conflict of law principles. If any term, clause, or provision of this Agreement is held invalid or unenforceable by a court of competent jurisdiction, such invalidity shall not affect the validity or enforceability of any other provision, and the remaining terms shall remain in full force and effect.

BY SIGNING BELOW, I ACKNOWLEDGE THAT I HAVE READ THIS ENTIRE DOCUMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
